### **ADMINISTRATIVE BUSINESS:**

# **SECRETARY / TREASURERS REPORT:**

Since the last meeting, the following have been paid: Thunder Bay Area Zone One for enhanced paging, Richard Baxter for mileage, David Harris for an expense report for the 911 activation mailout, Lynn Scott for postage, Minister of Finance for the OPP billing to the end of December, Minister of Finance for call taking and alerting, and the monthly honorariums. The PAP's to Hydro One, Tbaytel, Bell Canada, and Superior Propane have been withdrawn. Also, the first advance has been received from the MENDM. The current bank balance is \$67,649.09.

# **ONGOING BUSINESS:**
