Kathy then asked Deputy Chief Richard Baxter if he would be interested in stepping into the chief position. An inhabitant questioned Chief Johnson why she is stepping down and her answer was that she does not feel that her opinion was respected.

ONGOING BUSINESS:

Chief Johnson stated that it has been reasonably quiet. We have had a few calls to get the billing done by September. The roll out deck has been ordered and should be installed in the next week, and the door skins are being finalized and ordered and up.
